

Best Western® Contest Rules:

CONTEST PERIOD

Best Western® Contest (“Contest”) begins 12:01 a.m. CDT on Wednesday, November 1, 2017 and closes at 11:59 p.m. CST on Wednesday, December 27, 2017 (“Contest Period”).

SPONSOR

The Contest is sponsored by CAA Club Group (operating as CAA Manitoba) (“CAA Manitoba”).

WHO CAN ENTER

The Contest is open to residents of the Province of Manitoba who are 18 years of age or older as the date of entry for the Contest, with the following exceptions: employees and retirees of CAA Manitoba and its affiliates, partners, suppliers, representatives, agents, advertising and promotional agencies, the independent contest agency if any, and the household members and Immediate Family of any of the above are not eligible to participate in the Contest. For the purpose of these Contest Rules, “**Immediate Family**” means spouse, mother, father, brother, sister, son or daughter, whether or not they reside in the same household.

HOW TO ENTER

No purchase necessary. To register for the Contest and to receive one (1) Contest entry go to www.caamanitoba.com/contests to find the Contest Entry Form and follow the instructions provided. Complete the Entry Form with your first name, last name, email address, daytime telephone number, CAA Manitoba membership number, confirm you are of the legal age of majority in the Province of Manitoba, and indicate that you have read, understood, and accept the Official Rules by checking the appropriate box and select “Submit” to submit your entry. **Limit one (1) entry per membership per Contest (regardless of the email addresses, telephone numbers or addresses provided throughout the Contest Period).**

CAA members who are unable to enter online may also enter the Contest by writing your first name, last name, complete mailing address including street address, city, province and postal code on a card or sheet of paper not exceeding 8.5 X 11” and mail to CAA Rewards Contest, 870 Empress Street, Winnipeg, MB, R3G 3H3. You may enter once per membership per Contest, but each mail-in entry must be: (i) mailed in a separate envelope, bearing sufficient postage (ii) postmarked by no later than the end of the Contest Period; and (iii) must be received at the above address within the Contest Period. No responsibility will be taken for mail-in entries that are delayed, lost, misdirected or damaged.

All entries must be received by CAA Manitoba during the Contest Period. For online entries, proof of sending is not proof of receipt. For mail-in entries, proof of mailing is not proof of receipt.

If it is discovered that you attempted to enter more than once during the Contest Period, then all of your entries in this Contest will be disqualified. Multiple registrations during the Contest Period by the same person using any device or method to register multiple times or as multiple Contestants will result in disqualification.

Entries that are incomplete, late, lost, and/or irregular in any way or sent by an unauthorized method are automatically void and will not be eligible or accepted. Entries will only be accepted as described herein and will not be accepted by any other means.

PRIZE

There will be one (1) prize awarded. The prize consisting of:

One (1) Best Western® Gift Card (valued at \$200) and one (1) piece of carry-on luggage (valued at \$159.99). (individually a “Prize” collectively the “Prizes”)

If for any reason it is not possible to contact the winning entrant, despite customary diligent efforts, CAA Manitoba reserves the right to disqualify that entrant and select another entrant in their place. The initial selected entrant will have no recourse towards CAA Manitoba or anyone involved in the Contest.
