

“Get a CAA Travel Insurance Quote!” Contest Rules:

CONTEST PERIOD

Get a CAA Travel Insurance Quote Contest begins 12:00 a.m. CDT on October 1, 2017 and closes at 11:59 p.m. CDT on December 31, 2017.

SPONSOR

The Get a CAA Travel Insurance Quote Contest is sponsored by CAA Manitoba.

WHO CAN ENTER

Contest is open to residents of the Province of Manitoba who are 18 years of age or older, except for employees, retailers and agencies of the Canadian Automobile Association, CAA Manitoba, and the immediate family members of such persons or people that reside in the same household.

HOW TO ENTER

How to Enter: To register for the contest and to receive one (1) Contest entry, you must complete a CAA Travel Insurance quote online at https://www.caamanitoba.com/insurance_travel_insurance (Click the “Save Quote” button in step 2 and fill in your email address to confirm your quote).



Or enter at a CAA Manitoba service centre, or through the CAA Manitoba call centre, to be automatically entered into a draw for a chance to win one of 2 - \$1,000 CAA Travel Vouchers (Cdn). No purchase is necessary. Certain conditions apply. Limit of one (1) entry per household during the contest period. A mathematical skill-testing question must be answered correctly in order to claim the prize.

No Purchase Necessary: CAA members or non-members must provide a 500-1,000 word essay on why you believe travel insurance is an important purchase before travelling. Entries can be mailed to: Attn: Insurance Services – Get a Quote Contest, CAA Manitoba, 870 Empress St, Winnipeg, Manitoba, R3C 2Z3. Each entry must include your first name, last name, complete mailing address including street address, city, province and postal code, email address and phone number on a card or sheet of paper not exceeding 8.5 X 11”. Upon validation of the essay you will be automatically entered into the prize draw. You may only enter once per person. Each entry must be handwritten and must be received at the above address within the CONTEST PERIOD. No responsibility will be taken for entries that are delayed.

If it is discovered that you attempted to enter more than once during the Contest Period, then all of your entries in this Contest will be disqualified. PRIZES

A random draw for the 2 prize winners will take place at CAA Manitoba, 870 Empress St. Winnipeg, MB on Monday, January 8, 2018 at 10:00 a.m. The two winners will be selected from all eligible entries received. Chances of winning are dependent on the number of entries received.
